## **2011-2012 SEASON FVYTC PERFORMING ARTS CLASS POLICIES AND PROCEDURES**

The following policies and procedures will be enforced. These policies and may be amended and/or extended at any time.

1. All participants must be on time for class.
2. All participants must be properly attired for dance.  
Boys: Black Unitard (full one piece body suit) or very loose or stretch pants or sweat suit bottoms; tee shirt or sweat suit top; black jazz shoes or black soft-sole slippers.  
Girls: Black Unitard or leotard with tights; tee shirt with tights; jazz shoes or ballet slippers; hair must be pulled back and/or tied. No big or expensive jewelry of any kind is allowed.

3. No visitors are permitted in class, including parents unless cleared by the director or teacher in advance.
4. No unknown or unauthorized persons will be allowed to pick up a child. The parent/guardian must clear any such person/s with the director beforehand.
5. No child can wait outside the gate unless there is written permission from the parent or guardian.
6. No child can leave the theatre grounds such as to walk to the nearby store without written permission from parent or guardian.

**There will be a showcase production at the end of the program in late June. This includes at least 4 performances. Dates and times are to be announced. Rehearsals will begin approximately 2 months in advance. Listed below are the policies relating to the showcase:**

1. **Showcase dates cannot be changed.** Once the dates have been decided on, these dates will be final.
2. All students must be on time for rehearsals.
3. Rehearsals may involve 2 hours, 3 to 4 times on weekdays; and 4-5 hours, including a lunch break on Sat. & Sun.
4. All students must make every rehearsal called for unless excused by the director or teacher.
5. Parent/Guardian must notify the director or teacher immediately when there is a conflict with any rehearsal or class that has been scheduled.
6. **There can be no absences during the last 4 weeks of rehearsals.**
